
**MOTION TO PLACE FUNDS WITH  
CLERK**


NOW COMES the plaintiff, by and through her attorney, and hereby moves to place disputed funds with the Clerk of Superior Court and in support of this motion, says:

1. This action involves the question of whether defendants have the right to \$9,750 of proceeds from a personal injury claim based on \$3,000 advanced by Legal Bucks, LLC to plaintiff. These funds are presently in the Trust Account of Barron & Berry, LLP.
2. Plaintiff claims the advance and the approximately 100% annual interest defendants claim is illegal because, among other things, it constitutes Usury, Champerty, Maintenance, Illegal Gaming and Unfair and Deceptive Trade Practices among other causes of action that are set out in the Complaint that is being filed contemporaneously with this Motion.
3. Plaintiff brings this action for herself and all others in North Carolina who likewise received advances from defendants and she seeks to have her transaction and the transactions of the class members declared void.
4. Defendants claim their practices are legal and that they are entitled to the money.

THEREFORE, so there is no question that plaintiff is in breach of any obligation to defendants and that so defendants' interests, if any, are protected, plaintiff moves the court for an order placing the disputed funds with the Clerk of Superior Court pending the resolution of these claims.




